



THE SHORT ANSWER: NOT DIRECTLY.

Mortgage rates don't rise or fall just because it's an election year. Historical data from the Federal Reserve and lender Freddie Mac shows there is **no consistent pattern** of mortgage rates rising or falling simply because it's an election year.
